THE APPLICATION of the Plaintiff coming on for hearing at the Courthouse at 800 Smithe Street, Vancouver, B.C., on the 21st day of May, 2010, and on hearing Sharon Matthews, counsel for the Plaintiff, J. Kenneth McEwan QC, counsel for the Defendant, AU Optronics Corporation America, Gary Fraser, counsel for the Defendant, Chunghwa Picture Tubes, Ltd., Violet Allard, counsel for the Defendants, Samsung Electronics Canada Inc. and Samsung Electronics Co., Ltd., Paula J. Price, counsel for the Defendants, LG Display Co., Ltd. *fka* LG Philips LCD Co. Ltd. and LG Display America, Inc. *fka* LG Philips LCD America, Inc., H. THIS COURT ORDERS that:

 unless otherwise stated, the defined terms in this Order have the same meaning ascribed to them as they do in the Settlement Agreement dated May 11, 2009, attached as Schedule "A" to this Order (the "Settlement Agreement"). In addition to the definitions in the Settlement Agreement, the following definition shall also apply in this Order:

"Proportionate Liability" means that proportion of any judgment that, had they not settled, a court or other arbiter would have apportioned to the Settling Defendant and the Releasees, whether pursuant to the *pro rata*, proportionate fault, *pro tanto*, or another method;

- this action be certified as a class proceeding only as against the Defendant Chunghwa Picture Tubes, Ltd. (the "Settling Defendant") and for settlement purposes only;
- 3. the Settlement Class be defined as follows:

All persons resident in British Columbia who purchased LCD Products directly or indirectly from a Defendant, an entity affiliated with a Defendant, an Original Equipment Manufacturer or a Distributor in Canada during the Class Period, except Excluded Persons;

- 4. Kristopher Gruber be appointed as the Representative Plaintiff for the Settlement Class;
- 5. the proceeding be certified on the basis of the following issue which is common to the Settlement Class:

Did the Settling Defendant conspire to fix, raise, maintain or stabilize the prices of, or allocate markets and customers for, LCD Products in Canada during the Class Period? If so, what damages, if any, did the Class members suffer?;

- 6. the Settlement Agreement is fair, reasonable and in the best interest of the Settlement Class;
- 7. the Settlement Agreement is hereby approved pursuant to s. 35 of the *Class Proceedings Act*, R.S.B.C. 1996, c. 50 and shall be implemented in accordance with its terms. Where any term of this Order and the Settlement Agreement conflict, the terms contained in this Order shall govern;
- 8. the Settlement Agreement is incorporated by reference into and forms part of this Order and is binding upon the representative plaintiff and all Settlement Class Members;
- Settlement Class Members who wish to opt-out of this action must do so by sending a written election to opt-out, together with the information required in the Settlement Agreement, to the Claims Administrator, postmarked on or before the date which is sixty (60) days from the date of the first publication of the Notice of Certification and Settlement Approval;
- 10. any Settlement Class Member who has validly opted-out of this action is not bound by the Settlement Agreement and shall no longer participate or have the opportunity in the future to participate in this action;
- 11. any Settlement Class Member who has not validly opted-out of this action is bound by the Settlement Agreement and may not opt-out of this action in the future;
- 12. each Settlement Class Member who has not validly opted-out of this action shall consent and shall be deemed to have consented to the dismissal as against the Releasees of any Other Actions he, she or it has commenced, without costs and with prejudice;
- 13. each Other Action commenced in British Columbia by any Settlement Class Member who has not validly opted-out of this action shall be dismissed against the Releasees, without costs and with prejudice;

- 14. this Order, including the Settlement Agreement, is binding upon each Settlement Class Member who has not validly opted-out of this action including those persons who are minors or mentally incapable and the requirements of Rule 6 of the British Columbia Rules of Court are dispensed with in respect to this action;
- 15. in accordance with Section 7.3 of the Settlement Agreement, the use of the terms "Releasors" and "Released Claims" in this Order does not constitute a release of claims by the Settlement Class Members. Instead, each Settlement Class Member is deemed to covenant and undertake not to make any claim in any way nor to threaten, commence, or continue any proceeding in any jurisdiction against the Releasees in respect of or in relation to the Released Claims;
- 16. each Releasor who has not validly opted-out of this action shall not now or hereafter institute, continue, maintain or assert, either directly or indirectly, whether in Canada or elsewhere, on their own behalf or on behalf of any class or any other person, any action, suit, cause of action, claim or demand against any Releasee or any other person who may claim contribution or indemnity from any Releasee in respect of any Released Claim or any matter related thereto, except for the continuation of the Proceedings against the Non-Settling Defendants or unnamed co-conspirators;
- 17. the Releasees have released and shall be conclusively deemed to have forever and absolutely released each of the other from any and all claims for contribution and indemnity with respect to the Released Claims;
- 18. all claims for contribution and indemnity or other claims over, whether asserted or unasserted or asserted in a representative capacity, inclusive of interest, taxes and costs, relating to the Released Claims, which were or could have been brought by any Non-Settling Defendant or any other person or party against a Releasee, or by a Releasee against a Non-Settling Defendant or any other person or party, are barred, prohibited and enjoined in accordance with the terms of this Order (unless such claim is made in respect of a claim by a person who has validly opted-out of this action);

- 19. if, in the absence of paragraph 18 hereof, the Non-Settling Defendants would have the right to make claims for contribution and indemnity or other claims over, whether in equity or law, by statute or otherwise, from or against the Releasees:
 - a) the Plaintiff and the Settlement Class Members shall not claim or be entitled to recover from the Non-Settling Defendants that portion of any damages, costs or interest awarded in respect of any claim(s) on which judgment is entered that corresponds to the Proportionate Liability of the Releasees proven at trial or otherwise;
 - b) for greater certainty, the Plaintiff and Settlement Class Members shall limit their claims against the Non-Settling Defendants to, and shall be entitled to recover from the Non-Settling Defendants, only those claims for damages, costs and interest attributable to the Non-Settling Defendants' several liability to the Plaintiff and the Settlement Class Members, if any; such claims against the Non-Settling Defendants may be asserted on a joint and several basis as between the Non-Settling Defendants only; and
 - c) this Court shall have full authority to determine the Proportionate Liability at the trial or other disposition of this action, whether or not the Releasees remain in this action or appear at the trial or other disposition, and the Proportionate Liability shall be determined as if the Releasees are parties to this action for that purpose and any such finding by this Court in respect of the Proportionate Liability shall only apply in this action and shall not be binding on the Releasees in any other proceedings;
- 20. if, in the absence of paragraph 18 hereof, the Non-Settling Defendants would not have the right to make claims for contribution and indemnity or other claims over, whether in equity or law, by statute or otherwise, from or against the Releasees, then nothing in this Order is intended to or shall limit, restrict or affect any arguments which the Non-Settling Defendants may make regarding the reduction of any judgment against them in this action;

- 21. if this proceeding against the Non-Settling Defendants has been certified and all appeals or times to appeal related thereto have been exhausted, the Non-Settling Defendants shall be entitled to seek an Order, on motion to the Court, on at least ten (10) days notice to counsel for the Settling Defendant, that provides for the following:
 - (i) documentary discovery from the Settling Defendant in accordance with the British Columbia Rules of Court;
 - (ii) oral discovery of a representative of the Settling Defendant, the transcript of which may be read in at trial;
 - (iii) leave to serve a request to admit on the Settling Defendant in respect of factual matters; and
 - (iv) the production of a representative of the Settling Defendant to testify at trial, with such witness to be subject to cross-examination by counsel for the Non-Settling Defendants.

Notwithstanding any provision in this Order, on any motion brought pursuant to this paragraph 21 the Court may make such Orders as to costs and other terms as it considers appropriate;

- a Non-Settling Defendant may effect service of the motion(s) referred to in paragraph 21 above on the Settling Defendant by service on counsel of record for the Settling Defendant in this action;
- 23. for purposes of enforcement of this Order, this Court will retain an ongoing supervisory role and the Settling Defendant will attorn to the jurisdiction of this Court for these purposes;
- 24. except as provided herein, this Order does not affect any claims or causes of action that any Settlement Class Member has or may have against the Non-Settling Defendants or unnamed co-conspirators in this action;
- 25. the Releasees have no responsibility for and no liability whatsoever with respect to the administration of the Settlement Agreement;

- 26. the Settlement Amount be held in trust for the benefit of the Settlement Class, pending further order of the Court, which shall be sought by the Plaintiff on a motion in the action brought on notice to the Defendants;
- 27. this action be dismissed against the Settling Defendant without costs and with prejudice;
- 28. approval of the Settlement Agreement is contingent upon approval by the Ontario Court and the Quebec Court and that this Order shall have no force and effect if such approval is not secured in Ontario and Quebec;
- 29. the retainer agreement between Kristopher Gruber and Camp Fiorante Matthews be approved;
- 30. Class Counsel legal fees in the amount of \$469,336.00, plus applicable taxes, are approved;
- 31. Class Counsel disbursements in the amount of \$560,004.85, plus applicable taxes, are approved; and
- 32. the Class Counsel legal fees, disbursements and applicable taxes be paid from the Settlement Funds, payable pursuant to the terms of the Settlement Agreement.

CANADIAN LCD PANELS CLASS ACTION NATIONAL SETTLEMENT AGREEMENT

RECITALS

, in

A. WHEREAS the Proceedings have been commenced by the Plaintiffs in Ontario, Quebec and British Columbia which allege that the Settling Defendant participated in an unlawful conspiracy to raise, fix, maintain or stabilize the price of in Canada and/or to allocate markets and customers for the sale of LCD Panels in Canada, contrary to Part VI of the *Competition Act* and the common law;

B. WHEREAS the Settling Defendant does not admit, through the execution of this Settlement Agreement, any allegation of unlawful conduct alleged in the Proceedings;

C. WHEREAS the Plaintiffs and Class Counsel have reviewed and fully understand the terms of this Settlement Agreement and, based on their analyses of the facts and law applicable to the Plaintiffs' claims, and having regard to the burdens and expense in prosecuting the Proceedings, including the risks and uncertainties associated with trials and appeals, the Plaintiffs and Class Counsel have concluded that this Settlement Agreement is fair, reasonable and in the best interests of the Plaintiffs and the classes they seek to represent;

D. WHEREAS the Plaintiffs, Class Counsel and the Settling Defendant agree that neither this Settlement Agreement nor any statement made in the negotiation thereof shall be deemed or construed to be an admission by or evidence against the Settling Defendant or evidence of the truth of any of the Plaintiffs' allegations against the Settling Defendant, which the Settling Defendant expressly denies;

E. WHEREAS the Settling Defendant is entering into this Settlement Agreement in order to achieve a final and nation-wide resolution of all claims asserted or which could have been asserted against it by the Plaintiffs in the Proceedings, and to avoid further expense, inconvenience and the distraction of burdensome and protracted litigation;

F. WHEREAS the Parties therefore wish to, and hereby do, finally resolve on a national basis, without admission of liability, all of the Proceedings as against the Settling Defendant;

G. WHEREAS for the purposes of settlement only and contingent on approvals by the Courts as provided for in this Settlement Agreement, the Parties have consented to certification or authorization of the Proceedings as class proceedings and have consented to a Settlement Class and a Common Issue in each of the Proceedings; and

H. WHEREAS the Plaintiffs assert that they are adequate class representatives for the Settlement Classes and will seek to be appointed representative plaintiffs in their respective Proceedings;

NOW THEREFORE, in consideration of the covenants, agreements and releases set forth herein and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, it is agreed by the Parties that the Proceedings be settled and dismissed on the merits with prejudice as to the Settling Defendant only, without costs as to the Plaintiffs, the classes they seek to represent or the Settling Defendant, subject to the approval of the Courts, on the following terms and conditions:

SECTION 1 – DEFINITIONS

For the purpose of this Settlement Agreement only, including the Recitals and Schedules hereto:

(1) Account means an interest bearing trust account at a Canadian Schedule 1 bank in Ontario under the control of Siskinds LLP for the benefit of Settlement Class Members.

2.2 Motions for Approval

(1) The Plaintiffs shall bring motions before the Courts for orders approving the notices described in section 11, certifying or authorizing each of the Proceedings commenced in their respective jurisdictions as a class proceeding (for settlement purposes) and approving this Settlement Agreement.

(2) The Ontario order certifying the Proceeding and approving the Settlement Agreement referred to in section 2.2(1) shall be substantially in the form attached hereto as Schedule B. The Quebec and British Columbia orders authorizing or certifying the Proceedings and approving the Settlement Agreement referred to in section 2.2(1) shall be agreed upon by the Parties and shall mirror the substance and, where possible, the form of the Ontario order.

(3) This Settlement Agreement shall only become final on the Effective Date.

2.3 Pre-Motion Confidentiality

Until the first of the motions required by section 2.2 is brought, the Parties shall keep all of the terms of the Settlement Agreement confidential and shall not disclose them without the prior written consent of counsel for the Settling Defendant and Class Counsel, as the case may be, except as required for the purposes of financial reporting or the preparation of financial records (including tax returns and financial statements) or as otherwise required by law.

SECTION 3 – SETTLEMENT BENEFITS

3.1 Payment of Settlement Amount

(1) On or before January 31, 2010, the Settling Defendant shall pay the Settlement Amount to Siskinds LLP for deposit into the Account, in full satisfaction of the Released Claims against the Releasees.

(2) The Settling Defendant shall have no obligation to pay any amount in addition to the Settlement Amount, for any reason, pursuant to or in furtherance of this Settlement Agreement.

(3) Siskinds LLP shall maintain the Account as provided for in this Settlement Agreement. Siskinds LLP shall not pay out all or part of the monies in the Account, except in accordance with

3.2 Taxes and Interest

(2) Subject to section 3.2(3), all Canadian taxes payable on any interest which accrues on the Settlement Amount in the Account or otherwise in relation to the Settlement Amount shall be the responsibility of the Settlement Classes. Class Counsel shall be solely responsible to fulfill all tax reporting and payment requirements arising from the Settlement Amount in the Account, including any obligation to report taxable income and make tax payments. All taxes (including interest and penalties) due with respect to the income earned by the Settlement Amount shall be paid from the Account.

(3) The Settling Defendant shall have no responsibility to make any filings relating to the Account and will have no responsibility to pay tax on any income earned by the Settlement Amount or pay any taxes on the monies in the Account, unless this Settlement Agreement is terminated, in which case the interest earned on the Settlement Amount in the Account shall be paid to the Settling Defendant who, in such case, shall be responsible for the payment of all taxes on such interest.

3.3 Cooperation

Counsel for the Settling Defendant agree to be reasonably available as necessary to respond to Class Counsel's questions regarding the electronic transactional data produced by the Settling Defendant. If counsel for the Settling Defendant are unable to provide an adequate response to Class Counsel's questions, the Settling Defendant shall request that an employee of the Settling Defendant be reasonably available to Class Counsel to respond to Class Counsel's questions. The inability of the employee to respond to Class Counsel's questions or the failure of the employee to agree to make him or herself available to or otherwise cooperate with the Plaintiffs shall not constitute a breach or violation of this Settlement Agreement:

SECTION 5 - OPTING-OUT

5.1 Procedure

(1) A person may opt-out of the Proceedings by sending a written election to opt-out, signed by the person or the person's designee, by pre-paid mail, courier or fax to the Claims Administrator at an address to be identified in the notice contemplated by section 11 of this Settlement Agreement.

5.2 Opt-Out Report

Within thirty (30) days of the Opt-Out Deadline, the Claims Administrator shall provide to the Settling Defendant and Class Counsel, to the extent that such information is known by the Claims Administrator, the following information in respect of each person, if any, who has opted out of the Proceedings:

- (a) the person's full name, current address and telephone number;
- (b) the reasons for opting out;
- (c) the name(s) of each entity from whom the person purchased LCD Products during the Class Period; and
- (d) a copy of all information provided by that person in the opting-out process.

SECTION 6 - TERMINATION OF SETTLEMENT AGREEMENT

7.2 Release by Releasees

Upon the Effective Date, each Release forever and absolutely releases each of the other Releases from any and all claims for contribution or indemnity with respect to the Released Claims.

7.3 Covenant Not To Sue

Notwithstanding section 7.1, for any Settlement Class Members resident in any province or territory where the release of one tortfeasor is a release of all other tortfeasors, the Releasors do not release the Releasees but instead covenant and undertake not to make any claim in any way or to threaten, commence, or continue any proceeding in any jurisdiction against the Releasees in respect of or in relation to the Released Claims.

7.4 No Further Claims

The Releasors shall not now or hereafter institute, continue, maintain or assert, either directly or indirectly, whether in Canada or elsewhere, on their own behalf or on behalf of any class or any other person, any action, suit, cause of action, claim or demand against any Releasee or any other person who may claim contribution or indemnity from any Releasee in respect of any Released Claim or any matter related thereto, except for the continuation of the Proceedings against the Non-Settling Defendants or unnamed co-conspirators.

7.5 Dismissal of the Proceedings

The Proceedings shall be dismissed with prejudice and without costs as against the Settling Defendant.

7.6 Dismissal of Other Actions

(1) Each Settlement Class Member, who does not opt-out, shall be deemed to consent to the dismissal, without costs and with prejudice, of his, her or its Other Actions against the Releasees.

(2) All Other Actions commenced in any province or territory of Canada by any Settlement Class Member, who does not opt-out, shall be dismissed against the Releasees, without costs and with prejudice.

SECTION 8 - BAR ORDER AND OTHER CLAIMS

8.1 Bar Order

A bar order shall be granted by each of the Courts providing for the following:

If this Settlement Agreement is terminated, all information provided by the Settling Defendant pursuant to section 12.2(1) shall be dealt with in accordance with section 6.2(1)(d) and no record of the information so provided shall be retained by Class Counsel in any form whatsoever.

SECTION 13 – CLASS COUNSEL FEES AND ADMINISTRATION EXPENSES

(1) The costs of the notices referred to in section 11 of this Settlement Agreement and any costs associated with receiving opt outs shall be paid by Class Counsel or the Claims Administrator, if one has been appointed by the Courts, out of the Account.

(2) Class Counsel may seek the Courts' approval to pay Class Counsel Fees and Administration Expenses contemporaneous with seeking approval of this Settlement Agreement.

(3) Except as provided in section 13(1), Class Counsel Fees and Administration Expenses may only be paid out of the Account after the Effective Date.

(4) Class Counsel reserve the right to bring motions to the Courts for payment out of the Account for any future adverse cost awards to a maximum of CDN \$250,000 and future disbursements to a maximum of CDN \$250,000.
