AT THE JUDICIAL MANAGEMENT CONFERENCE coming on for hearing at the Courthouse, 800 Smithe Street, Vancouver, BC, on 09/Mar/2017 and in the presence of Naomi Kovak, on behalf of the Claims Administrator and counsel for the plaintiff, Barry Jim Burnell; Mark Underhill, counsel for the sub-plaintiff, Lorne Nels David Iverson; and no one appearing on behalf of the defendant, the Attorney General of Canada;

THIS COURT ORDERS that:

1. The court directs that the payout of settlement funds to claimants may be made in stages;
2. The court directs that Camp Fiorante Mathews Mogerman ("CFM") may, as the Claims Administrator, pay settlement funds to claimants who submitted objection forms or claim forms outside of the 45 day limit for objections, or outside the 90 day limit for accepting claims, as long as the forms were received by CFM on or before March 3, 2017;

3. Disbursements for the purposes of settlement administration in the amount of \$6,005.92 plus \$361.13 in taxes are approved as fair and reasonable and shall be paid to CFM, the Claims Administrator;

4. The court directs that a further hearing ^{to 86 J.} will be set down in, ~~or about, the middle of~~ ^{86 J.} ~~May 2017~~ to:

- (a) address any outstanding challenges or issues with the settlement administration, and to approve the final payments of settlement amounts; and
- (b) approve the payment of any outstanding disbursements associated with the administration of the settlement.
