

# PROPOSED SETTLEMENTS IN CANADIAN AUTO PARTS PRICE-FIXING CLASS ACTIONS

## BETWEEN 1999 AND 2017, DID YOU OR YOUR COMPANY:

1. Purchase and/or lease a new or used automotive vehicle in Canada or for import into Canada; and/or
2. Purchase any of the following parts for installation into an automotive vehicle: automatic transmission fluid warmers, automotive wire harness systems and/or radiators?

If so, you might be affected by settlements reached in the class actions.

## SETTLEMENTS ACHIEVED

Settlements have been reached with the following defendants:

- Yazaki Systems Technologies GmbH (formerly S-Y Systems Technologies Europe GmbH) (“S-Y Systems”) for \$50,000 for the period between 1999 and 2014 in the automotive wire harness systems action.
- T.RAD Co., Ltd. and T.RAD North America, Inc. for \$113,476.33 for the period between 2002 and 2017 in the automatic transmission fluid warmers action.
- T.RAD Co., Ltd. and T.RAD North America, Inc. for \$1,053,975.67 for the period between 2000 and 2017 in the radiators action.



The settlements are a compromise of disputed claims and are not an admission of liability, wrongdoing or fault by any of the parties. The settlements require court approval in Ontario, British Columbia and/or Quebec.

Settlement class members have the following options:

1. Tell the Court what you think about the proposed settlements in writing or speak to the Court at the hearings;
2. Opt out of the automatic transmission fluid warmers and/or radiators actions; and/or
3. Do nothing.

## PROPOSED DISTRIBUTION OF THE AUTOMOTIVE WIRE HARNESS SYSTEMS SETTLEMENT FUNDS

The courts will also be asked to approve the distribution of the S-Y Systems settlement funds in accordance with the distribution protocol previously approved in the automotive wire harness systems action, a copy of which is available online at: [www.siskinds.com/auto-parts-automotive-wire-harness-systems/](http://www.siskinds.com/auto-parts-automotive-wire-harness-systems/) or by contacting Class Counsel.

The other settlement funds (plus interest, minus approved fees and expenses) are being held in an interest-bearing trust account for the benefit of settlement class members.
