JUDGMENT  
DECEMBER 10, 2021

POPESCU C.J.Q.B.

---

[1] The representative plaintiff seeks court approval of a proposed settlement with Royal Bank of Canada, Canadian Imperial Bank of Commerce, Toronto-Dominion Bank, Bank of Montreal and Bank of Nova Scotia. This proceeding is one of five certified class action proceedings brought collectively in the Courts of Saskatchewan, British Columbia, Alberta, Ontario and Quebec.

[2] The other four actions are as follows:

(a) *9085-4886 Québec Inc. v Visa Canada Corporation*, Superior Court of Quebec, No 500-06-000549-1010 (Montreal);

(b) *Coburn and Watson's Metropolitan Home v Bank of Montreal*, No. VLC-S-S-112003, Vancouver Registry [BC Proceeding];


(c) *Bancroft-Snell v Visa Canada Corporation*, OSCJ No CV-11-426591CP (Toronto); and

(d) *Macaronies Hair Club and Laser Center Inc, operating as Fuze Salon v B of A Canada*, File No 1203 18531 (Edmonton).

- [3] The representative plaintiff has applied for:
- (a) Court approval of the settlement of \$120,000,000.00;
  - (b) Approval of the distribution plan;
  - (c) The appointment of Epig Class Actions Services Canada Inc. as the claims administrator;
  - (d) The appointment of Hilsott Notification as the notice administrator;
  - (e) Approval of the form of the notice informing class members about the claims process;
  - (f) The approval of the plan setting out how the Claims Notice will be distributed; and
  - (g) Approval of Class Counsel Fees and Honorariums.
- [4] Previous settlement agreements and class counsel fees within this action, but pertaining to other Defendants, have been approved. See *Hello Baby Equipment Inc. v B of A Canada Bank*, 2015 SKQB 410.
- [5] The BC Proceeding has been the lead action.
- [6] On December 6, 2021 the applications were conducted jointly before all five courts by Webex.
- [7] At the conclusion, the decisions of the courts were reserved.

[8] I have now had the opportunity to review the reasons for judgment of Weatherill J. See *Coburn and Watson's Metropolitan Home v Bank of Montreal*, 2021 BCSC 2398. I agree with those reasons in their entirety.

[9] Accordingly, I adopt those reasons as my own in relation to the Saskatchewan action, with necessary modification as the context requires.
